

User Guide - Primary or Special School Registration

Use this form to apply to register a primary or special school which holds a roll number assigned by the Department of Education and Skills. Primary and special schools come within the terms of the Charities Act 2009, as they fall within the definition of an 'education body' in the Act and, as such, are legally required to apply for inclusion on the Register of Charities.

In this form there are six tabs to complete: Details, Purpose, Address, Board, Further Info and Declaration which are explained below in detail.

1. Details

Here you must enter the official name of your school, as well as its roll number. If your school is known by any other name, please add it.

You must also enter the date that your school was established and the number of teachers employed by the school (include full and part-time, and permanent and temporary).

2. Purpose

The charitable purpose 'Advancement of education' and your main objects, section 9 of the Education Act 1998, have been pre-populated. If your school has a different main object, you can edit the pre-populated information by clicking in the body of the text.

3. Address

Please enter your school's physical address in this tab. This must be a physical address and cannot be a PO Box address. You can enter the full address or the Eircode in the Search Address box and it will auto-populate with your details. If your school is in an area with many non-unique addresses (such as a rural townland) you may need to enter your full address manually, including your Eircode.

If your correspondence address is different to your school's physical address please add it here. If not, there is no need to add another address.

You must also enter your school's telephone number and email address in this section. If your school has a website you can also add it here.

4. Board

The members of the Board of Management are the charity trustees for the school.

The minimum number of board members is set to one (1) by default, but enter the number relevant to your school. Please note that, except in special circumstances, the minimum number required is four (4) for a school with one teacher, and eight (8) for a school with more than one teacher.

Please enter the name, start date on the Board and residential addresses of all the members of the Board of Management, by clicking on 'Add Board Member'. You will also be asked to indicate if the board member is the Chairperson.

It is a mandatory requirement under section 39(5)(d) of the Charities Act 2009 that residential addresses are provided, however they will not be made public on the Register. Phone number and email addresses may be entered, but are not mandatory, and will not be made public on the Register.

Please note that each member of the Board of Management must not be disqualified, under section 55 of the Charities Act 2009, from being a trustee of a charitable organisation. This includes, but is not limited to:

- is adjudicated bankrupt;
- makes a composition or arrangement with creditors;
- is convicted on indictment of an offence;
- is sentenced to a term of imprisonment by a court of competent jurisdiction.


The name, position type and start date of members of the Board of Management will be published on the Public Register of Charities.

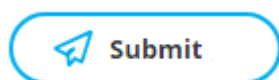
5. Further information

6. Declaration

This section allows you to review and certify the information you have provided. If you are satisfied that it is correct, and it has been approved by the trustees for submission, you should submit your changes. The privacy terms and Statement of Information Practices should be read and accepted.

Once you are satisfied with this you can click on  **Preview** button to download a PDF of your information, and then click on




button to submit your application to the Charities Regulator.

Tá bunscoileanna agus scoileanna speisialta faoi raon feidhme théarmaí an Achta Carthanas 2009 mar go dtagann siad faoin sainmhíniú ar ‘comhlacht oideachais’ san Acht. Dá bhrí sin, tá ceangal dlí orthu iarratas a dhéanamh ar a gcur ar áireamh sa Chlár Carthanas.

Tugann an tsiombail ‘súile’ le fios go mbeidh an fhaisnéis a iontráiltear i réimse ar leith le feiceáil ar an gClár poiblí.

Is réimsí éigeantacha iad na réimsí atá marcáilte le réiltín dearg agus ní mór iad a chomhlánú.

Tá an rogha ‘sábháil dréacht’ le feiceáil ar gach táb den fhoirm agus cumasaítear leis an rogha sin duit do dhul chun cinn a shábháil. (Tabhair faoi deara: toisc nach sábháiltear aon obair go huathoibríoch, molaimid duit dréachtaí a shábháil go rialta le linn duit dul tríd an bhfoirm).

1. Sonraí

Ní mór duit ainm oifigiúil do scoile agus a huimhir rolla a iontráil anseo. Má thugtar aon ainm eile ar do scoil, tabhair an t-ainm sin anseo.

Ní mór duit freisin an dáta a bunaíodh do scoil agus an líon múinteoirí a fhostaíonn an scoil (lena n-áirítear múinteoirí lánaimseartha, páirtaimseartha, buana agus sealadacha) a iontráil freisin.

2. Cuspóir

Líonadh isteach cheana féin an cuspóir carthanúil ‘Oideachas a chur ar aghaidh’ agus do phríomhchuspóirí de réir alt 9 den Acht Oideachais, 1998. Má tá príomhchuspóir difriúil ag do scoil, is féidir leat an fhaisnéis atá líonta isteach cheana féin a chur in eagar ach cliceáil ar chorp an téacs.

3. Seoladh

Iontráil seoladh fisiciúil do scoile sa táb seo. Ní féidir Bosca Oifig Phoist a thabhairt mar sheoladh fisiciúil – ní mór gur seoladh fisiciúil é. Is féidir leat an seoladh iomlán nó an tÉirchód a iontráil sa bhosca ‘Cuardaigh Seoladh’ agus líonfar isteach é go huathoibríoch le do shonraí. Má tá do scoil lonnaithe i limistéar ina bhfuil a lán seoltaí neamhuathúla (amhail baile fearainn tuaithe), is féidir go mbeidh ort do sheoladh iomlán, lena n-áirítear d’Éirchód, a iontráil de láimh.

Má tá do sheoladh comhfhreagrais difriúil le seoladh fisiciúil do scoile, cuir an seoladh sin leis anseo. Mura bhfuil, ní gá seoladh eile a chur leis.

Ní mór duit uimhir theileafóin agus seoladh ríomhphoist do scoile a iontráil sa rannán seo freisin. Má tá suíomh Gréasáin ag do scoil, is féidir leat é a chur leis anseo.

4. Bord

Is iad na comhaltaí den Bhord Bainistíochta na hiontaobhaithe carthanais don scoil.

Tá an líon íosta comhaltaí boird socraithe mar dhuine amháin (1) mar réamhshocrú. Mar sin féin, iontráil an líon atá ábhartha do do scoil. Tabhair faoi deara gurb amhlaidh, seachas i gcúinsí speisialta, gurb é ceathrar (4) an líon íosta a éilítear i gcás scoil a bhfuil múinteoir amháin aici agus gurb é ochtar (8) an líon íosta a éilítear i gcás scoil a bhfuil níos mó ná múinteoir amháin aici.

Iontráil an t-ainm, an dáta tosaigh ar an mBord agus na seoltaí cónaithe do gach comhalta den Bhord Bainistíochta ach cliceáil ar ‘Cuir Comhalta Boird Leis’. Iarrfar ort a chur in iúl freisin cé acu atá nó nach bhfuil an comhalta boird ar an gCathaoirleach.

Tá sé ina cheanglas éigeantach faoi alt 39(5)(d) den Acht Carthanas 2009 go gcuirtear seoltaí cónaithe ar fáil. Mar sin féin, ní fhoilseofar iad go poiblí ar an gClár. Is féidir uimhir theileafóin agus seoltaí ríomhphoist a chur isteach. Mar sin féin, níl siad éigeantach agus ní fhoilseofar iad go poiblí ar an gClár.

Tabhair faoi deara nach mór do chomhalta ar bith den Bhord Bainistíochta gan a bheith dícháilithe, faoi alt 55 den Acht Carthanas 2009, chun bheith ina (h)iontaobhaí de chuid eagraíochta carthanúla. Folaíonn sé sin na nithe seo, ach gan a bheith teoranta dóibh:

- go mbreithneofar ina fhéimheach nó ina féimheach é nó í;
- go ndéanfaidh sé nó sí imshocraíocht nó comhshocraíocht le creidiúnaithe;
- go gciontófar é ar díotáil i gcion;
- go gcuirfidh cúirt dlínse inniúla téarma príosúnachta air nó uirthi.

Déanfar an t-ainm, an cineál poist agus an dáta tosaigh do chomhaltaí an Bhoird Bhainistíochta a fhoilsiú ar an gClár poiblí Carthanas.

5. Tuilleadh Faisnéise

Is féidir aon doiciméid eile a mheasann tú a bheith iomchuí nó a bhfuil mar aidhm leo tacú le d'iarratas a uaslódáil (i bhformáid PDF amháin) sa rannán seo.

6. Dearbhú

Sa rannán seo, is féidir leat an fhaisnéis atá tugtha agat a athbhreithniú agus a dheimhniú. Más deimhin leat go bhfuil an fhaisnéis ceart, agus má cheadaigh na hiontaobhaithe í lena cur isteach, ba cheart duit d'athruithe a chur isteach. Ba cheart na téarmaí príobháideachais agus an Ráiteas faoi Chleachtas Faisnéise a léamh agus ba cheart glacadh leo.
